- I agree not to assert any claims or actions against the Program or Princeton in connection with any harm that Participant, Parent or our property might suffer as a result of Participant’s participation in the Program.
- I agree to defend, indemnify and hold Princeton harmless from and against any claims, demands, damages, liabilities, expenses, losses or every kind and nature, including but not limited to attorney’s fees and costs, (collectively, “Costs”) sustained or alleged to have been sustained in connection with or arising from Participant’s participation in the Program.
